# KippsDeSanto's Aerospace / Defense & Government Services 2019 M&A Survey

KippsDeSanto is pleased to share its second annual survey of merger and acquisition ("M&A") activity and sentiment in the Aerospace / Defense and Government Services sectors

In this study, we asked key dealmakers from relevant sectors to share their predictions about M&A deal activity and valuations over the next year. We also asked them to share their insights on strategic drivers of M&A activity, including government elections and predictions on the 2019 credit market

Respondents are optimistic about the overall economy and M&A activity in the near-to medium-term. They expect M&A volume and valuations to remain strong, similar to 2018 levels, due in part to robust defense spending and economic confidence









#### **M&A Trends & Activity**

Heightened deal activity in 3Q19 is driving annual transaction volume, putting the market on pace for a record year as a flurry of aerospace deals supplemented by stable defense and government services announcements made 3Q19 the single biggest quarter in M&A over the last 5 years; this high transaction volume demonstrates acquirers' continued reliance on M&A to supplement organic growth, penetrate new customers and geographies, and bolster coveted capabilities



#### EV / LTM EBITDA Public Market Valuation Trends(1)


Public market valuations remain near all-time highs with LTM EBITDA multiples for both defense and government services indices experiencing a quarter-over-quarter uptick, while the aerospace sector has seen a slight dip compared to the prior quarter





## Capital Markets LTM Performance<sup>(1)</sup>

Headwinds resulting from the ongoing U.S.-China trade war have been partially offset by favorable federal funding in the form of a longer-term budget deal, which saw government spending reach an all time high; coupled with low interest rates and healthy corporate earnings, the macroeconomic environment supports continued performance across the aerospace / defense & government services sectors





Stellar *air traffic demand* driven by a strong economy has helped bolster aerospace stocks, with gains of 2.7% in 3Q19 and 24.5% YTD

Boeing's 737 MAX remains grounded with the company failing to book a single order for the MAX aircraft for six consecutive months; conversely, Airbus has seen profits soar, driven partially by order increases for narrow-body aircraft that rival the 737 MAX



Strong and stable defense budgets have helped defense indices continue to outperform the broader market for most of the past two years, notching a 11.2% increase in 3Q19 and 39.3% increase YTD

Raytheon's stock has increased 15.0% against the backdrop of *increases in order backlogs and an anticipated merger with UTC* 



#### **Government Services**

The government services sector has *continued to outperform the broader market,* driven by government spending on modernization, cloud capabilities and nextgen IT, which has driven the index to grow by 5.6% in 3Q19 and 56.8% YTD

ICF International leads the pack with gains of 14.2% in 3Q19

#### Space Startups See Big Payouts in Push to the Moon

The Trump administration has laid out an *ambitious timeline for NASA's Artemis program* – to land astronauts on the moon by 2024 and establish a sustained human presence there by 2028



The race to build *space-bound rockets* has historically been reserved for industrial and technology giants. *Startups are carving out crucial roles* within the massive undertaking. Companies such as *Lunar Outpost, ispace Inc., and Lithoz* are securing awards to deliver equipment to the surface of the moon, hunt down lunar ice that can be transformed into breathable air, building dust-tolerant tool changers, and deploying rovers

#### U.S. Aims to Block Chinese Acquisition

U.S. officials are seeking to *scuttle the pending Chinese acquisition* of a Ukrainian aerospace company Motor Sich

Aerospace is one of 10 component sectors of "Buy China," a strategic government plan to upgrade the quality of the country's manufacturing





The acquisition would boost China's military buildup and civilian aviation capacity, giving Beijing vital defense technology

As one of the world's *foremost manufacturers* of helicopter and airplane engines, Motor Sich has supplied engines for the bulk of the Russian military-helicopter fleet

Extended capability of unmanned systems across land, sea, air, and space





#### U.S. Strengthens Indo-Pacific Presence


Secretary of Defense Mark Esper calls for expanded basing investments in key Indo-Pacific locations to preserve freedom of navigation

U.S. continues to promote *foreign military sales* to allies in the region to maintain allied military presence in lockstep with its own military deployments and investments





## Government Services Update

#### DoD on Artificial Intelligence

The budget for the DoD's *Joint Artificial Intelligence Center ("JAIC")* is jumping from \$93 million in GFY19 to \$268 million in GFY20. The JAIC has three objectives it hopes to achieve with the additional funding:

A project focusing on using *machine learning* to identify targets such as

enemy camps



The Joint Common Foundation which will focus on providing data and tools to enable engineers to deploy

solutions to Warfighters



A collaboration with the *Defense Innovation Unit* and military surgeons to analyze health records, classify medical imagery, and mitigate PTSD





#### Navy Creating Elevated CIO Office



Following several large-scale breaches and poor performance on a department-wide cybersecurity review in March, the Navy has responded by creating an elevated *Chief Information Officer ("CIO")* role




Appointee will lead a team dedicated to improving the department's information management, cybersecurity, data, digital strategy, and business systems



The new CIO office will proactively develop a strategy for the Navy, utilizing second-, third-, and fourthtier suppliers to build and enforce stricter cybersecurity standards

#### Prioritization of 5G

Top DoD scientists indicated that *5G technologies* will see a substantial increase in investment due to "how ubiquitous the network is likely to be in the near future and how important it is that the United States be part of its development."



With the acknowledgement that the private sector will be the *driving force* behind 5G development, the increased investment in the technology should result in *robust contract opportunities* in the space
