

M&A Trends & Activity

- Deal activity continued its momentum from 4Q20, driven by priorities of the new administration, the need to modernize legacy systems, enhance citizen engagement, and maintain readiness and defense posture related to national security
- These deal market drivers emboldened companies, especially private equity firms and blank-check acquisition firms (further detailed on page 5) during 1Q21 to pursue deals, particularly in the defense sector



- The Aerospace sector saw another strong quarter of M&A activity, continuing off of the 4Q20 momentum, indicating further optimism in the sector fueled by growth in air traffic levels as the U.S. continues a successful vaccine rollout
- Defense and Government Technology Services ("GTS") M&A activity remains insulated from downward pressure affecting industries with more commercial exposure; buyer confidence remains strong and there was a record 93 deals announced for the quarter between the two sectors



A&D Special Purpose Acquisition Company ("SPAC") Activity

- SPAC M&A activity has increased substantially during the past few years and has particularly picked up during the last six months, with over 10 aerospace and defense ("A&D") companies going public via a SPAC in the last two quarters
- A&D companies have piqued the interest of SPACs because they are capital intensive and can therefore benefit from investments of large pools of capital during short time frames





EV / NTM EBITDA Public Market Valuation Trends


 Aerospace public multiples were boosted in 1Q21 by the continued market rebound, while low NTM EBITDA metrics across the board contributed to a higher median multiple. Defense also saw an uptick, while GTS multiples remained largely in line with the past quarter






Equity Capital Markets Performance

- Equity markets continued their resurgence in 1Q21 due to positive momentum and growing optimism of the economic recovery, falling COVID-19 case numbers, improvements in the vaccine rollout, a new \$1.9 trillion fiscal package, and continued monetary policy support
- Stocks encountered volatility in the middle of the quarter due to spikes in bond yields; however, the Federal Reserve is not contemplating near-term tightening and interest rates remain historically low







Commercial aerospace stocks continue to perform well, building off the momentum from the final quarter of 2020 as Boeing continues to receive a high volume of 737 MAX orders, two years after the jet was initially grounded

Shares of *Astronics* (*NASDAQ: ATRO*) rose 36.4%, as it *continues to win key contracts* spanning from aircraft power distribution to manufacturing subassemblies for missiles

Defense

Defense firms *lead the way* in 1Q21, and industry officials remain *optimistic* that the Biden administration will *keep the defense budget relatively flat,* which would be better than expected given recent and future potential stimulus to buoy the economy

Shares of AeroVironment (NASDAQ: AVAV) rose 33.6%, driven by strong earnings performance, and three transformative acquisitions that the Company is confident will accelerate success / value creation



Government Technology Services

The GTS index *underperformed* the broader market in 1Q21 as investors exhibited fears that *added government spending* due to COVID-19 could slow government contracting revenues 2021 and beyond

Shares of *ICF International (NASDAQ: ICFI) rose 17.6%*, as it delivered *impressive 4Q20 results* driven by strong federal government and commercial revenues. The Company has also *won several large-scale contracts* (total contracts won for the quarter was \$525 million)

Aerospace and Defense Update

Continued Market Consolidation through Sizable, Transformational Deals

2019 and 2020 saw *record levels of transactions valued over \$1B*, a trend that has seen continued momentum throughout the first quarter of 2021

Select Drivers of Largescale M&A Deals



Modernization → Companies also turn to M&A to build out new capabilities, technologies, and efficiencies aimed to align with modernization and innovation priorities

Financing → The current cost of capital is driving aggressive capital allocation strategies geared towards future growth Taxes → The expectation of corporate tax increases in 2021 has driven M&A activity, and Biden's proposed corporate tax hikes to fund the \$2T infrastructure package

Defense Secretary Austin Outlines Top DoD Priorities



President Biden's appointee for Secretary of Defense, General Lloyd J. Austin III, announced the top priorities of the Defense Department are *defeating COVID-*19 and *maintaining a competitive advantage against China*

China: the Nation's Top Pacing Threat

Austin named China as the nation's *number one pacing challenge*, ensuring the U.S. will take a coordinated foreign policy approach to the growing superpower

China increased its defense budget to \$208B, still \$700B less than the United States. China's budget grew 6.8% as they seek to modernize their military, specifically their naval operations

In addition to China, the new Defense Secretary also addressed growing threats from *Russia, Iran, and North Korea*

In order to ensure a credible deterrence to the accelerating, advanced threats, innovation and modernization will remain a mission-critical priority area under the new administration, which will require advances in joint warfighting concepts and investments in the Joint Artificial Intelligence Center ("JAIC")

Aviation Sector Resiliency throughout Previous Economic Recoveries

U.S. air travel—measured by TSA airport passenger screenings—fell to a *6-month low in January 2021* as COVID-19 infections and travel restrictions continued to hinder the industry's recovery

It is expected that vaccinations will fuel a significant rebound in travel demand in the coming months, although it could take years to return to pre-pandemic air traffic levels

Air passenger traffic has historically rebounded quickly following economic shocks with the largest percentage growth gains over the past two decades experienced during economic recoveries

Aerospace Sector vs. S&P 500 over Past Decade



The Aerospace sector significantly outperformed the broader market over the last decade, reflecting the high air travel growth rate and stability experienced in the aviation industry prior to the pandemic



Government Technology Services Update

Technology Modernization Fund is Just a Start to Address Legacy System Underinvestment

Congress has turned its attention to *funding federal IT upgrades* through the Technology Modernization fund, with \$1B in funding included in the American Rescue Plan Act of 2021 passed on March 6, 2021. which would provide funding through September 30, 2025. The funding will be allocated as follows:



Data Analytics Must Be Front and Center

Data generated by government agencies continue to grow at astronomic rates, and as this grows, the need to manage, secure, and analyze this data becomes vital.

Modern Data Platforms → The private sector has benefited from existing tools that have already been tried and tested, and government organizations should look to take advantage of such tools to effectively manage / analyze the ever-increasing volume of data

Increasing Need for 5G Network Development in Space

The Air Force's Space Command is interested in finding a way to get 5G wireless connectivity to work in space, which would improve data transportation for ground- and space-based communications

Recent Lockheed / Omnispace Deal Exhibits this Need Formulatina into Action



The Companies signed a "strategic interest gareement" for joint development of 5G mobile broadband capability from space, in a deal signed March 23

With this hybrid 5G network, Lockheed Martin aims to provide the ability to transmit large amounts of data at high speeds and low latency to the government market, which requires seamless, reliable alobal *communications* for essential applications

5G Network Development Points of Interest

Massive Multiple Input Multiple Output ("MIMO") Networks → Antenna expansion for spacecraft communications

Radio Access Network ("RAN") Slicing → Address the deployment of multiple logical networks as independent business operations on a common physical infrastructure

Artificial Intelligence → Provide message stream recognition and content analysis to prioritize stream data rate by content type

Veritas has been a major player in the recent acceleration of acquisition activity in the Federal IT market with the acquisition of Harris Corporation's Government Services Business in 2017 (now "Peraton"), the Northrop Grumman Federal IT business in 2021, and the pending acquisition of Perspecta. Perspecta, Peraton, and Northrop's IT business brought in \$3.5B in IT obligations in fiscal 2020, more than all other IT contractors with the exception of General Dynamics Corporation

Combination Benefits

Access to large-scale contracts → Alliant 2 Large Business, IT Support Services Contract II, Chief Information Officer – Solutions and Partners 3, etc. Intelligence Community → Peraton and Perspecta can potentially benefit from Northrop's strength in this space

Customer Access → The combination would allow access to various customer relationships beyond their shared connection with different agencies and bureaus
